The Process - Legislative


- Bills
 - Committee Review
 - Floor Discussion
 - Passed by House and Senate
- Signed or Vetoed
- Incorporated into the Statutes
- Must be consistent with the Constitution
- May defer detail to Agency

The Process - Executive

- The Administrative Process
 - Proposed Rule
 - Comment Period
 - Final Rule
 - Regulation
- Must stay within the scope of the Statute
- Sub-regulatory
 - Opinions
 - Administrative Hearings

The Process - Judicial

- Constitutional Challenges
- Administrative Challenges
- Procedural and Substantive Requirements
- Outcome is based on application of the law to a specific set of facts
- Court/Appellate Levels
 - District Court
 - Court of Appeals
 - Supreme Court




